1. WELCOME & OPENING REMARKS

2. PRESENTATION BY CHIEF SECURITY OFFICER

5. FINANCIAL REPORT -- CHIEF FINANCIAL OFFICER (CFO), MRS. KAREN BAPTISTE

September 2023 vs September 2022 - Total Revenue YTD for the month ending September 2023 was \$27M compared to \$18.2M in September 2022. This is a 43% increase in aeronautical income and a 77% increase in non-aeronautical income.

Total expenses of \$26.7M in September 2023, up by 23% when compared to \$21.8M in September 2022.

September 2023 closed with a Net Operating Loss (after adjusting for PFC fees) of \$5M vs \$7.2M loss at the same time last year.

Year on Year Comparative September 2023, 2022, 2019 - Total Revenue YTD in September 2023 was \$27M compared to 2019 of \$31.1M. This is 87% of 2019. Total Expenses at the end of September 2023 was just under \$26.9M which is 21% above September 2019 expenses.

September 2023 vs Budget YTD – Total Revenue YTD in September 2023 was \$27.1M – exceeding budget by 23% or by \$5M.

Total Expenses at the end of September 2023 was \$26.9M - exceeding budget by 10% or \$2.5M.

Just about all areas are exceeding budget, except for staff costs, under by 5% or \$740K.


